As all of our members know, TCBA is an all-volunteer organization. Each member contributes what they can to keep the organization running smoothly. Right now, TCBA has a need for someone with computer skills and familiarity with accounting. On Dec. 31, TCBA's Treasurer is stepping down. Would you be willing to take on the role?

Qualifications:

The ability to work with one or more computer-based software programs (like Microsoft Office) is a must, as TCBA's accounting system is online.

Attention to detail is a must.

Some accounting experience is important, although, for the right candidate, not absolutely necessary.

Experience with Microsoft Excel would be helpful.

What TCBA will offer you:

TCBA's accounting procedures -- both manual and those using QuickBooks -- are fully documented, in extreme detail. If you can read and follow directions, you can function as TCBA's Treasurer!

Extensive, hands-on training with the current Treasurer will be offered, starting well in advance of Dec. 31, and to whatever degree you wish.

Ongoing support by the current Treasurer will be available after the new Treasurer takes office on Jan. 1.

Usually, the Treasurer use their own desktop/laptop computer and printer to run QuickBooks and other software programs. However, TCBA would consider providing a desktop computer. A TCBA-owned printer is available if needed. (Note that support for Microsoft's Windows 7 operating system expires this Dec. 31, so a Microsoft Windows 10 or an Apple operating system would be required.)

Additional details:

TCBA's Treasurer is the organization's chief financial officer, in charge of its accounting system, bank accounts, and legal filings.

TCBA's accounting system is QuickBooks Plus, which is online. It runs best using Google Chrome.

The Treasurer will be given access to TCBA's ClubExpress system, which is linked to one of TCBA's bank accounts and which is used to process various charges and credits.

The Treasurer position requires a one-year commitment (Jan. 1 - Dec. 31), although TCBA is hoping for a two-year commitment.
